How?	All financial companies need to share customers' personal information to run their everyday business. What we do	
How does Hendrick Porsche protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. In addition, we maintain physical, electronic and procedural safeguards.
How does Hendrick Porsche collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none"> ■ Apply for financing ■ Provide Account Information or Provide Employment Information ■ Give us your Contact Information ■ Show your Government Issued ID We also collect your personal information from others, such as credit bureaus, affiliates or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> ■ Sharing for affiliates' everyday business purposes—information about your creditworthiness ■ Affiliates from using your information to market to you ■ Sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing.
What happens when I limit my sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> ■ <i>Our affiliates include dealerships with a Hendrick name; Hendrick Automotive Group; and Hendrick Autoguard, Inc.</i>
Non-affiliates	<i>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</i> <ul style="list-style-type: none"> ■ <i>Non-affiliates we share with can include auto manufacturers, financial institutions, insurance companies and direct marketing companies.</i>
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> ■ <i>Our joint marketing partners include dealerships, financial institutions and insurance companies.</i>
